After the Apple Fest was over we received very positive responses from many of our local citizens and local business owners complimenting the festival, and one business owner said that last year's event generated their biggest sales day ever!

Mason, Texas is known as the Gem of the Hill Country and we strive to make this the gem of all apple festivals!!! The festival marks the 27th harvest season of Mason's own Sonlight Apple Orchard.

The fest has been organized by Mason County Apple Fest, which is a nonprofit IRS Code Section 501(c)(3) corporation, formed to benefit Mason Schools.

Vendor Rules and Regulations

1. Please decorate your booth in an apple theme...to be in keeping with our Apple Fest.
Note: Booth decorations will be judged, and the winner will receive a free 1 night stay at The Apple Cottage Bed and Breakfast right here in Beautiful Historic Mason.
2. Exhibitor must be equipped with all your own display equipment including tables, chairs, and heavy duty extensions cords if electricity is needed.
3. No flea market or novelties. In an effort to maintain quality for the show, exhibitors are required to send photos of their work. We reserve the right to bar items or activities in bad taste, that are inappropriate, or that do not meet the rules. We reserve the right to limit duplications of the same craft items and a decision will be made, assuming equal quality, on a first come first-served basis.
4. Although most booths have shade for at least part of the day, shade is not guaranteed. Bringing a canopy or covering would be in your best interest and to guarantee shade.
5. Please secure your display against the wind, because you will be responsible for any damages caused by your display to other exhibitors merchandise and/or to customers.
6. Sales tax rate in Mason is 8.25%, as you are responsible for collecting and reporting that to the State Comptroller.
7. No pets on the Courthouse Lawn.
8. There will be no refunds after August 1, 2011 and no refunds should bad weather occur.
9. Sign and return the applicable entry form with a check or money order and photos. If this is your first year with us you can also email photos to masoncountyapplefest@live.com.
10. Vendors are responsible for having appropriate safety equipment. Vendors with electric or heated appliances must have a fire extinguisher readily available.
